1 Previous CLS engagement work

Prior to the ELC-FS testing study materials, processes and survey questions research, the CLS study team engaged extensively with young people and parents from a wide variety of socioeconomic and ethnic backgrounds. The aim of this engagement was to inform the design of the ELC-FS and ensure a diverse set of participant voices were considered. The CLS study team also sought feedback via research with fathers who live separately from their babies and child's other parent. During this research, fathers provided their views on the study design, including who should be asked to be interviewed and the content and look of the materials and the questionnaire.

This feedback from young people and parents has been carefully incorporated into every aspect of the ELC-FS, including the design of the questionnaire and materials that was tested in this qualitative research. The table below gives an overview of this engagement work:

2.2 Information sheet

All about our research and what taking part would involve

We would like to invite parents to take part in a research interview to understand how best to include parents in future research about children.

For this research we specifically want to speak to parents with a child aged 2 years or under.

We want to hear from **parents in a variety of different circumstances** across the UK, including from those who live with the child's other parent, to single parents, and those who live with their child full time to those who have less frequent or no contact with their child. We are keen to speak to parents from all of these different types of circumstances to make sure that we include a range of views in our research.

Who is the research for?

Ipsos, an independent research organisation, is carrying out this research on behalf of a project team led by the Centre for Longitudinal Studies (CLS) at University College London (UCL). CLS carries out research studies exploring the experiences and development of children as they grow up in the UK. CLS are currently planning for a new study called Generation New Era. To help with their plans we would like to get your views on how CLS might invite parents to take part in their future study and the types of survey questions that the new study might include.

The Directors of the study are Professor Lisa Calderwood, Professor Pasco Fearon and Professor Alissa Goodman.

What do Ipsos want to find out?

We want to ask parents about:

- The type of information that is provided to parents when inviting them to take part in research about their child/ ren. To do this we will show you some examples of the type of information that might be used to invite parents to take part in future research.
- The types of questions that could be included in future research with parents. We will show you some questions that could be included in future surveys and ask you for your view on these topics and how clear the questions are.

What would taking part involve?

We would like you to take part in either a **video interview** (using MS Teams) or **in-person interview** with one of our lpsos researchers. During the interview we will talk to you in more detail about your views on the topics mentioned above.

The interview will last around **1 hour**, and we can schedule the interview to happen at a time and place that is convenient for you. As a thank you for your time, you will receive **£45** for taking part in this research. This will be paid as a BACS transfer, or can be provided as a Love2Shop e-voucher if you prefer.

If you take part in a video interview we would like to send you some information to look at during the interview. We will send this in the post and will ask you not to open the envelope until told to do so by the Ipsos researcher. This is because we would like you to tell you what order to look at the information and would like to capture your initial reactions to the information. We will be sending you the following:

- Some copies of letters and leaflets that could be used in the future to invite parents to take part in a research study about their child.
- A copy of some questions that could be included in future surveys with parents.

We will ask you for your permission to send you this information in the post.

After this first research interview, we may contact you again to invite you to take part in a follow-up research interview during the next 12 months. This interview will cover similar topics as described

above. This would be a separate conversation and those that take part would receive an additional thank you for taking part. We will ask your permission to get back in touch with you.

Do I have to take part?

No. **Taking part is completely voluntary.** You can also choose to not answer individual questions or stop the interview completely at any time. Even if you agree to take part now you can change your mind. You do not have to give a reason why.

Participation in this research will not impact any state benefits you might be receiving.

Will you record what I say?

Yes. We would like to audio record the interview, but we will ask you if that is OK before we start. The reason for recording the interview is to help us to remember what you have said when we write up our findings in the report. **Ipsos will keep your personal data and responses in strict confidence**. We will only securely share recorded material(s) from the interview with the Ipsos research team and our transcription agency partner, Take Note. Your responses will be used for research purposes and no personal information will be shared with any third parties. We will follow the current laws, such as the General Data Protection Regulations (GDPR), when we store and access this information. **You can contact us after you have taken part if you would prefer us to delete your information**.

What will happen to the information I provide?

Ipsos adheres to the Market Research Society (MRS) code of conduct, which will be followed throughout the research process. Our supplier organisation Criteria Fieldwork Ltd is responsible for the recruitment of volunteers to take part in this study and will collect your personal information, with your consent, as part of this process. Criteria will securely pass this information to Ipsos, including your name, your contact number, your email address, your gender, age, which part of the UK you live in and ethnicity. All this data will be securely stored and deleted one year after the research study ends. No personal information will be shared with CLS, Ipsos alone will hold this data.

After the interview, everything you say to a researcher will be anonymised. We will not tell anyone that you have spoken to us, or share anything that identifies you, unless you or someone else is in danger of serious harm.

Ipsos will write a report for CLS to summarise the findings. The report may include case studies and direct quotes from participants - however, we will not mention any personal details that might identify you or your child. You can withdraw your consent to take part in this research right up until the end of November 2022, when we will be finalising the report.

3 Stage 1 research materials

3.1 Topic guide

Research Objectives

The aim of this interview is to gather feedback on engagement materials for the ELC-FS as well as cognitively test questions for inclusion in the survey. To understand this, we will be exploring their views on:

- Engagement materials
 - Opt-out letter (referred to as Letter 1)
 - Advance letter (referred to as Letter 2)
 - Advance booklet (referred to as Booklet)
- A selection of survey questions

Notes:

Interviews will be carried out either via MS Teams video call or in person. Each interview will last up to **1** hour, and each participant is being provided with a thank you of £45 either by BACs or Love2Shop evoucher.

This topic guide is intended to guide the discussion with interviewees. It will be used to ensure the topics are covered with participants but not all questions will necessarily be asked, or the exact wording used. The order of some questions may also differ as the moderator will be led by the participant, ensuring that the interview reflects the participant's views and experiences.

- Letter 1 (opt-out letter) this will explain why they have been selected and what would happen if they take part and notification of how to opt-out.
- Letter 2 (advance letter) this will reiterate what taking part involves. It will be received in conjunction with the advance booklet
- **Booklet (advance booklet)** to encourage participation, provide further information about the study, why taking part is important and further clarifications.

Moderators: please do not use terminology opt-out letter, advance letter or advance booklet with participants, please just refer to them as 'letter 1, letter 2 and booklet.

When speaking to Own-Household Fathers, be sure to acknowledge that we know fathers can have different types of involvement with their children. At recruitment, fathers will have been asked about any involvement they have with their child – check sample profile to see what level of contact they have and reflect this in the interview. Please note that we should not use the term 'own household father' when speaking to participants, instead please use the term 'fathers that do not live with their child full-time'.



What is Generation New Era?

Generation New Era is a groundbreaking new scientific study of several thousand children born in 2022, and their families. Every baby is special, but those born today belong to a one-of-a-kind generation. The pandemic and the cost-of-living crisis have brought unique challenges for mothers and fathers like you, your children and your futures.

How will it make a difference?

Generation New Era will provide vital new scientific insights into the health and development of children growing up in our changing world, and will be used by researchers, governments and service providers to improve the lives of children and their families in the UK.

Your family has been specially chosen to be part of this important scientific study, that will benefit the lives of families and children for many years to come.



What sort of study is Generation New Era?

Generation New Era is a special kind of study called a birth cohort study. These studies follow children from birth throughout their lives. They show how children grow and develop, and how childhood experiences affect later lives.

The UK has been a world leader in this kind of research for more than 70 years. There are currently four national birth cohort studies of people born in 1946, 1958, 1970 and 2000. These studies have followed the lives of over 60,000 people: through early life, school, leaving home, getting a job or starting a family of their own. You may have heard or read about them.

Why are these studies important?

The findings from these studies have been used to help design services to support children and families, including the most vulnerable in our society. For example, evidence from the UK Millennium Cohort Study (of children born in 2000-2) has helped pave the way for changes to schools' admissions rules in England, so that parents of children born in the summer can delay when they start school.



By being a part of Generation New Era and sharing your experiences, you can help shape the future for your family and other families like yours.

Why do we want to hear from you?

We want to hear from you because there is no one quite like your child and your family. For the study findings to benefit all kinds of families, we need to hear from many different families, from across the UK, including yours.

By including families from all nations and regions of the UK, and from all backgrounds and cultures, we can build a full picture of the lives of this generation of children and give everyone a chance to be heard.



People who have taken part in previous UK cohorts often ask, "if I haven't faced many difficulties in my life, is the information I give you still helpful?". Yes, it absolutely is. Your home and family; your work situation (including any maternity or paternity leave); your health and wellbeing; your experience of giving birth (if this applies to you); your parenting approach and relationship with your baby; the support you receive from people in your life; any services you or your baby use; and any childcare arrangements.

Why are we asking this?

Your baby's first year is completely intertwined with your own life as their parent. Knowing what your life is like and how you are experiencing being a parent is vital to get the full picture of your baby's life.

We will also ask some wider questions about you and your family, including other children, finances and where you live.

These topics have been carefully chosen with advice from parents and children, as well as researchers and policymakers, to ensure we are asking about the most important issues for children's lives.

If you do your interview in person with an interviewer, you will be asked to answer some of these questions privately on the interviewer's computer.

You do not have to answer any questions you don't want to, but we hope you will enjoy thinking about your baby's first year.



What if I have twins or triplets?

We would like to ask you about all your babies if you have twins, triplets or more! Some of the questions we ask will only need to be answered once (e.g. questions about yourself) but other questions will need to be repeated for each baby (e.g. about each baby's habits and how they are developing).

What will I get for taking part?

Each parent who takes part will receive a voucher as a thank you for their time. The voucher can be spent in a range of high street shops. The interviewer will either hand you a gift card at the end of the interview, or you will receive an e-voucher if you take part in the survey online or by telephone.



Will I get to know the findings?

So that you can see how your participation is making a difference, we will regularly share important research findings from the study with you, and the changes made possible by your participation.

The findings from Generation New Era will be published in reports and scientific papers, and may be reported in newspapers, and on the TV and radio. None of these findings will identify individual people.

Will I get any feedback?

We will not provide any individual feedback to you about your family or your child. This is because research does not look at results for individuals – only for groups.

The interview will give you an opportunity to reflect on your life as a parent and your baby's development.

People who've taken part in previous studies like this have told us they have really enjoyed taking part.



Who runs the study?

Ipsos is carrying out the interviews for Generation New Era. They were chosen because they are experts in this kind of research. Their survey interviewers are specially trained and carefully chosen to work on this study. Ipsos is an independent research organisation that must follow the rules of the Market Research Society Code of Conduct. Further information about Ipsos can be found at: <website>.

The Centre for Longitudinal Studies (CLS), at University College London (UCL), is in charge of the study. CLS is a leading research centre for birth cohort studies, and UCL is one of the world's leading universities.

The study team also includes other universities and organisations from around the UK, including Swansea University in Wales, the University of Edinburgh in Scotland and Ulster University in Northern Ireland.

Generation New Era is funded by the Economic and Social Research Council, the UK's leading academic funder of social research.



Who has approved this research?

This research has been reviewed by an independent group of people, called a Research Ethics Committee, committed to protect your safety, rights, wellbeing and dignity. This study has been reviewed and approved by the NHS's Research Ethics Committee.

Confidentiality and Security

The information you give is completely confidential under law, in accordance with the General Data Protection Regulation. This means that any information you give is always kept separately from information that could identify you (such as your name and address). The information you give will be kept entirely confidential from other members of your family and from any services, agencies or income benefits that you or your baby uses or receives.

What will happen to the information I give?

The information you give will be put together with the answers from all the people who are interviewed throughout the United Kingdom.

These are made securely available for researchers via the UK Data Service and other trusted research repositories. The information is used for research purposes only.

You won't be named in any reports, and no names are made public.

We make sure that there is never any information in reports that could identify someone.

Your data will be stored securely and retained until no longer required by the study.

You do not have to take part if you do not want to, and you can choose to leave the study at any time, without having to give a reason.

Who is responsible for processing the information I give?

The data controller for this project is University College London (UCL). A data controller is the organisation that determines the way personal data is processed, and for what reason. UCL's legal basis for using your information is for 'a task in the public interest' under the General Data Protection Regulation.



5.1 Topic guide

The aim of this interview is to gather feedback on participant facing booklet content covering data linkage to administrative and geographical data, biosamples, confidentiality and security, and operational linkages and respective materials as part of the ELC-FS. Adding information from administrative records

Government departments and agencies, such as the National Health Service (NHS) or Department for Work and Pensions, routinely collect information about all of us to help them plan and provide the services we need. This information is stored in administrative records.

We would like to add information from the following records to your study responses:

- Your health, education, work and benefits and social care administrative records; and,
- Your child's health, education and social care administrative records.

This will help build a more complete picture of your lives.

If your child's other parent takes part, we would also like to add information from their administrative records. This includes mothers and fathers, and parents who do not live with their child's other parent.

It's your choice

It is your choice which records are added to the information collected about you and your child in the study, and if you don't wish to do this you can still take part in the interview. You can decide to add information from all of these records,



from just some of them, or to add nothing at all. The interviewer will explain how you can let us know your decision, and you can change your mind at any time. Although only one parent will need to decide about adding information from your baby's records, you may wish to discuss this with your child's other parent.

The information we would like to add relates to your and your child's past, present and future circumstances. Because this study is designed to understand how children get on in the long term, we will continue to add information from you and your child's records on an ongoing basis. Once your child is an adult, they will have an opportunity to decide whether they would be happy for us to continue to add this information from their own records, or not

Adding information from your and your child's records will not affect your or your child's services, rights, treatment or any health insurance. It will not affect your benefits or tax.

We also want to add information about the local area or property where you live. This could be information about air pollution levels, energy efficiency of the property or other characteristics of your property or local area. These geographical data are not about an individual but refer to an area or a dwelling. Frequently, these geographical data are publicly available.

We plan to add information about where you live for all participants in the study, but if you prefer that we don't add this information to your study responses then please let us know using the details on the back of this booklet.

Why is adding information important?

Adding information about you and your child from administrative records and about where you live from geographical data is important as it helps to build a fuller picture of your lives. It makes the study even more useful for researchers and policymakers, who will use this information to improve public services and local areas for everyone.

For example, adding information from NHS administrative records can help researchers better understand the factors that affect the health of children and their parents, by providing more detailed information about health conditions and treatments. It can also help understand how well NHS services are meeting families' health needs.

Where we live has a huge impact on many aspects of life, so understanding more about where you live and your local area is very useful for research. For example, research on a similar study of children born in the early 2000s has shown that exposure to air pollution may be linked to children doing less well on average on some cognitive development tasks, which has helped highlight the importance of improving air quality, including close to schools and children's playgrounds. Researchers will also be able to look at things like whether living close to parks and other green spaces has an impact on health and well-being.

6.4 Advance booklet pages: Adding information about your and your baby's genes

Adding information about your and your baby's genes

We would like to add genetic information about you and your baby to the study to help understand how genes influence people's lives and children's growth and development.

We will ask you to swab the inside of your baby's mouth to collect an oral fluid sample, and we will use this to extract a DNA sample.

We will also ask biological parents to provide a saliva sample so that we can extract a sample of your DNA too. This includes mothers and fathers, including any biological parents who are living apart from their baby's other parent.

To thank you for your contribution, we will provide a separate additional £5 voucher for your sample and your baby's sample.





Do you and your child have to give a sample?

It's completely up to you whether or not to give these samples, and if you don't wish to do this you can still take part in the interview. Samples will only be collected from babies with permission from a parent, and although we only require one parent to agree to this, you may wish to discuss this decision with your child's other parent.

If you do decide to do this, the DNA samples will be stored securely and added to your survey responses for research about genes.

What are genes and DNA?

DNA is the genetic material in every cell of the body including blood, skin, saliva and hair. Genes are made up of sections of DNA which is the set of instructions for how our bodies are put together. They are the biological way that children inherit

characteristics from their parents. Everyone has a slightly different set of genes – so they are like our own personal recipe book. They don't determine what our lives are like, but together with the environments around us, they play an important role. Combining all these different things in the same study can help reveal what's driven by our genes, what isn't and how our genes and our environment work together.

Why is it important to study genes and DNA?

Studies like Generation New Era have already helped improve the care given to people with common diseases. One of the earlier birth cohorts in the UK, which is following people born in 1958, collected DNA from its study members in the early 2000s. Their contribution enabled ground-breaking scientific research and discoveries that led to new treatments for common conditions like diabetes, bipolar disorder, and inflammatory diseases.

This is the first time a national UK birth cohort study will collect DNA samples when the children are babies, rather than when they are older. By doing this at the start of the study Generation New Era can provide new scientific insights into the relative importance of genes and other factors in relation to children's growth and development in the early years.

Why is it important to collect DNA samples from biological parents as well as habies?

Collecting samples from biological mothers and fathers as well as children will make the genetic information available for research in Generation New Era as complete and inclusive as possible.

Each child's genes come from both their mother and father, so the value of the genetic information is increased greatly if we are able to look at both biological parents. For example, genes can have different effects depending on whether they come from the mother or father. DNA from parents will let us explore these differences. This is why – when looking at complex conditions such as asthma, obesity or diabetes – we need to look at DNA from parents as well as children. Analysing DNA from parents will allow researchers to understand which genes are passed from parent to child, and how parents' genes influence their children's lives as well as their own.

How are the samples collected?

Parents will be asked to take the oral fluid sample from their baby. Your interviewer will give you a special sterile swab to use and explain what to do. We ask that you brush the swab lightly inside your child's mouth on their gums. It is quick and simple to do. It does not hurt, and typically takes under a minute.

To collect your own sample, the interviewer will ask you to spit some saliva into a small container. It is very easy and can be done in private. Only about half a teaspoon of saliva is needed. This typically takes about 5 minutes.

Ideally the samples should be taken while the interviewer is present. However, if this is not convenient, or if you are completing the interview online, the sample collection kit can be left with you to do another time.



Will all parents be asked to give a sample?

As some of the parents who take part in Generation New Era will not be biologically related to their child, the interviewer will ask some questions about this to establish who is eligible to give a sample. If you have any queries or concerns about this, please visit our website link> or speak to your interviewer.

What will happen to the samples?

The interviewer will post the samples to a research laboratory at the University of Bristol which is licensed by the Human Tissue Authority. A sample of DNA will be extracted from the samples and stored for genetic research in the future. The saliva and oral fluid samples will not be retained.



The DNA samples will be stored securely and anonymously, and treated in strict confidence in accordance with the Data Protection Act, the General Data Protection Regulations (GDPR), and the Human Tissue Act. Your family's name and address will not be attached to the saliva and oral fluid sample when it is sent to the laboratory. Any researchers using the DNA samples will not have access to your family's name and address or any other details that could identify you personally.

What will the DNA samples be used for?

The DNA samples will be used for research purposes only. Researchers who want to use the DNA samples for genetic research will have to apply for permission to an independent committee with expertise in genetics and in overseeing and safeguarding access to the samples. After thorough review, permission to use the samples is only given to qualified researchers who can show that the samples will be used for genuine research purposes for the benefit of the public. Researchers from commercial organisations would usually be partnered with public organisations (such as the NHS or universities), except under circumstances of exceptional public benefit, and any use by commercial organisations would be for research purposes only.

The DNA samples will never be used for paternity testing or human cloning. Your DNA will never be given to lawyers or insurance companies.

The tests that will be done on your DNA are for research purposes, and are not the same as clinical genetic tests. The results cannot be used for individual diagnosis. As such, we will not routinely feed back your individual results.

If you have any concerns about genetic conditions you are advised to speak to a medical professional.

What if you change your mind?

You can change your mind about allowing the use of your child's DNA until they are an adult, or your own DNA at any time, without giving any reasons (see details at the end of this booklet). When your child is an adult they can withdraw permission for the storage and use of their own DNA.

Who runs the study?

Ipsos is carrying out the interviews for Generation New Era. They were chosen because they are experts in this kind of research. Their survey interviewers are specially trained and carefully chosen to work on this study. Ipsos is an independent research organisation that must follow the rules of the Market Research Society Code of Conduct. Further information about Ipsos can be found at: <website>.

The Centre for Longitudinal Studies (CLS), at University College London (UCL), is in charge of the study. CLS is the UK's leading research centre for birth cohort studies, and runs national studies of people born in 1958, 1970 and 2000. UCL is one of the world's leading universities.

The study team also includes universities from around the UK - Swansea University in Wales, the University of Edinburgh in Scotland and Ulster University in Northern Ireland.

Generation New Era is funded by the Economic and Social Research Council, the UK's leading academic funder of social research.

Who has approved this research?

This research has been reviewed and approved by an NHS Research Ethics Committee, an independent group of people committed to protect your safety, rights, wellbeing and dignity.

Who has approved access to my child's birth records?

Your family's details have been provided to the study by NHS Digital in England and Wales, National Records of Scotland and Public Health Scotland or Northern Ireland Maternity Systems. This access has been approved by special committees in each UK country to allow this.

What will happen to the information I give?

The information is used for research purposes only. Your survey responses will be put together with the answers from all the people who are interviewed throughout the United Kingdom. These are made securely available for researchers via the UK Data Service and other trusted research repositories. This data does not contain any names, addresses, or other personal details that could directly identify individuals in the study. Researchers using the data will not know who the information has come from, or who is in the study.

You won't be named in any reports, and no names are made public. Reports never include any information that could identify an individual in the study.

The information you give is treated in strict confidence, in accordance with the General Data Protection Regulation (GDPR). Your survey responses are always kept separately from information that could identify you (such as your name and address). The information you give will be kept entirely confidential from other members of your family and from organisations who provide services or administer benefits that you or your baby may use or receive.

In exceptional circumstances your confidentiality may be broken, for example, if something you tell us indicates that someone is at risk of harm.

Your study information is kept securely and will be retained until no longer required by the study.

What if I choose not to take part, or withdraw from the study?

You do not have to take part in Generation New Era if you do not want to, and you have the right to withdraw from the research at any stage, without having to give a reason. We will retain and continue to use your information unless you tell us not to, including for the purposes of understanding who does and doesn't take part.

Who is responsible for the study information?

The data controller for the study is University College London (UCL). A data controller is the organisation that determines the way personal data is processed, and for what reason. UCL's legal basis for using your information is for 'a task in the public interest' under the General Data Protection Regulation.





