Feedback from the consultation



We would like to extend our sincere thanks to everyone who responded to the consultation on the joint NCDS-BCS70 sweep. All contributions were carefully reviewed by the study team, and we sought guidance from our Scientific Advisory Network to help prioritise the suggestions received.

Below, we provide a summary of the feedback and our responses. To support clarity and transparency, all responses have been anonymised and summarised. Where appropriate, similar points have been grouped together. This approach is intended to make the feedback easier to follow, but please be assured that every individual response was considered in full.

While we greatly appreciate all input, it has not been possible to accommodate every request. The survey is limited to 50 minutes in length, and we must balance the need to retain core longitudinal content, introduce new measures, and maintain participant engagement.

The summary below outlines the key themes raised, the decisions made, and the rationale behind them. Where relevant, we reference new questions included in the draft questionnaire, available on the <u>CLS website</u>.

Suggestions on Theme 1: Family, relationships and identity

Caring responsibilities	Numerous requests were received to expand questions on caring responsibilities. Prior sweeps have focused primarily on caring for parents. It was suggested that questions are expanded to cover all caring responsibilities.	A new module on caring responsibilities based on questions asked in ELSA and Understanding Society has been added. Questions cover caring responsibilities in the household, caring responsibilities outside of the household, who provides care to, nature of care provided and total hours of care provided(questions CARHOM through CAREHRS). Care provided to grandchildren is covered separately - replicating previous NCDS/BCS70 sweeps, please see GRANDC through GCCARHM.
Caring responsibilities	To capture if parents are living in the household and if the cohort member thinks they will need to care for them in the future and are making changes to facilitate this.	We collect information on whether parents/parents-in-law are living in the household (HHNUMWH). We have also added a new question to cover the reasons why they are living with the cohort member (PARWHYLIVE). Questions have been added on care provision (see above), both inside and outside of the household, but we have not added a question on future care needs of parents due to space constraints.
Caring responsibilities	To cover caring for grandchildren/how much time spent and what activities they do. Is this care provided on a more 'formal' basis to allow children to work? Are grandchildren living nearby?	Questions on caring for grandchildren have been repeated from NCDS Age 62 and BCS Age 51 Surveys (GRANDC through GCCARHM). We have not this time added a question on proximity of grandchildren due to space constraints.
Children	Reasons for not having children or reasons for not having 'more' children.	BCS70 participants without children were asked the reasons for this at age 42 and age 51. We have included a question for NCDS and BCS70 participants this time (WHYNOC). (We have not added a question for those with children on why they have not had more).

Discrimination	Experience of discrimination and harassment due to age, sex, gender, sexual orientation, religion, social class, accent etc.	We will collect details on identity but not discrimination/harassment due to this. To be considered again for future sweeps.
Domestic labour	Questions covering the division of domestic (unpaid) labour within the household	Due to space constraints, we were unable to add these questions. These questions were asked in the BCS70 Age 51 Survey.
Gender identity	Include a question on gender identity	We have added a question on gender identity (CMSEX2 and CMGENDER).
Identity	Ask about sexual identity	We have added a question on sexual identity (SXID).
Mental load and emotional labour	Mental load / emotional labour: project managing a household, caring responsibilities	We are not including the division of labour in the household questions as these were asked in previous BCS70 surveys. We have added more extensive questions on caring responsibilities, please see more on this above.
Neighbourhood	Neighbourhood characteristics - in addition to linkage to also collect personal views and aspects on factors such as access to grocery stores,	Linkage to geographical indicators will continue based on address at interview. Questions on neighbourhood have been included (repeated from previous sweeps) covering 'belonging to a neighbourhood' and 'frequency of taking to neighbours' (q31 and q32).

Perceived social mobility	Perceived social mobility	We have added a question on social class identity (repeated from BCS70 Age 42, see CLASS)
Personality	Questions covering personality disposition of study member - to look further into stability of personality over time and how this is a predictor of partnerships, health, wellbeing and mental health. To have direct alignment of adult personality with childhood items.	We have not added personality questions this time around. Detailed personality questions were asked in the BCS70 Age 51 Survey and NCDS Age 50 Survey. Personality traits are relatively stable in older age and the personality questions are too lengthy to administer in this short web survey.
Pets	Whether have pets - a companion in old age/encourages walking	Repeated question asked in BCS70 Age 51 – PSC (see PETS).
Reflective life review	Include essay-style, reflective questions—similar to those in previous sweeps—to enhance analysis of sentiment and attitudes. Example: "Now that you are 68 years old, looking back on your life, what stands out to you, and how have these experiences shaped who you are today?"	We welcome this idea and propose using a similar question from ELSA: "Thinking back over your life, with its wide variety of enjoyable as well as difficult experiences, please write about three aspects of your life that have been especially important to you, and how they affected you." Suggestions include mirroring those from the Crime Survey for England and Wales. Questions to cover own experiences as well as experiences as business owner/work and contact with CJS. Questions covering Intimate Partner Violence and Abuse (IPVA) as well as abuse by other family members	This is an important topic and was discussed with our Scientific Advisory Network. Concerns were raised about the sensitivity of these questions for this sweep. The BCS70 Age 51 Survey very recently asked questions on IPVA. This could be considered for the next major sweep. For now, we have added life events questions asking: "Have you, or an immediate family member, been subject to abuse, attack or threat for another reason" and "Have you or an immediate family member been a victim of crime." Unfortunately due to the time constraints we have in this questionnaire we have not been able to add a specific question related to discrimination at work due to age. However, for those transitioning in and out of work, we capture reasons for their move which could indicate some of the barriers faced such as ill health (in WPREAS as a potential retirement reason, CLJYEND for leaving work, UMEMPY for reason of unemployment).
Benefit receipt	Important to ascertain whether participants are receiving benefits	We will have a question on sources of income which will include the most commonly received benefits as answer options (SRCINC08). Space constraints mean we cannot this time ask about income from each benefit received individually.
Economic activity changes	Include questions on changes in occupation, including those who continue working after retirement, participation in voluntary work, and shifts in working hours (e.g. full-time to part-time).	The economic activity history section will capture this information.
Financial expectations	Include questions on financial expectations—e.g. expected expenditure over the next 10 years, saving for social care costs, perceptions of pension adequacy, and plans for passing on wealth.	While these topics are not asked directly, the survey includes questions on savings, debt, mortgage payments, and pensions to build a detailed picture of current financial circumstances and future planning. We also cover financial expectations through questions such as:
		"What are the chances that at some point in the future you will not have enough financial resources to meet your needs?" (YLQ40m) "What are the chances you will ever move to a nursing home or require

We have included the question, "How well would you say you personally are managing financially these days?" which was used in previous sweeps (see FINNOW). However, we have not asked specifically about reducing spending on essentials due to rising costs or confidence in meeting costs, although questions on financial expectations cover future finances (as outlined above).
Housing expectations	Include questions on expected future house moves, reasons for moving, how long respondents expect to stay in their current property, and plans for downsizing.	We have not covered intensions to move in the future but we do ask about reasons for moves which have happened - where downsizing is an option (HOMEG). The expectations module also includes a question about the likelihood of moving into a care home/nursing home in the future (YLQ40f).
Housing expectations	Include questions on whether people are renting or plan to rent in retirement, and whether they can afford these housing costs or have concerns about meeting them.	We will establish whether participants are currently renting (TENCK-TENURE). We have not specifically asked about expectations to rent in later life. The expectations module does however include a question which captures concerns about meeting living expenses in future (YLQ40m).
Housing quality	Include questions on housing quality, heating, overcrowding, satisfaction, and linkage to more detailed housing data.	We have repeated questions from previous sweeps on housing which include tenure and number of rooms (TENCK - TENURE, NUMROOMS), which in combination with information we will collect about number of people in the home can be used to derive a measure of overcrowding. We have also included a question on damp (DAMP), and a question on satisfaction with housing (HOMSAT).

Income	Important to capture income from all sources - including from owned property	Space constraints mean that we have had to reduce the level of detail collected with regard to the different components of income. We have included a question on different sources of income (SRCINC08) - and will follow this with a question asking for total household income from all sources. It will not be possible to collect income from each source separately on this occasion.
Inheritance tax	Include questions on inheritance tax and any measures taken to limit or avoid it.	We did not feel that NCDS and BCS70 were the most suitable studies to cover this topic
Intergenerational financial mobility	Include questions that allow comparison of income and financial circumstances across generations.	Childhood sweeps collected information about family income. Adult sweeps have collected information about participant income. This data can be used to compare circumstances across generations.
Intergenerational transfers	Include questions on inherited wealth and intergenerational transfers—particularly support given to children, how inheritance is used (e.g. for retirement planning or pensions), and broader patterns of wealth transfer.	This was asked in detail in the previous NCDS sweep and to a lesser extent in the previous sweep of BCS70. After careful consideration we have concluded that there will not be scope to include these questions in the web survey, though we envisage repeating these questions again in the next major sweep.

Recommended tools include the Retirement Resources Inventory (RRI), Reasons for Retirement Questionnaire (RRQ), Retirement Experiences Questionnaire (REQ), Self-perceived Stress in Retirement Scale, and the Adjustment to Retirement Scale.	It has not been possible to include these specific scales in the web survey - but we do have extensive measures of well-being, which can be used in combination with the economic activity history data to compare wellbeing amongst those who are retired and those who are not.

Receipt of care - are they receiving care from family/friends or via the council/private	We have added a new section covering the caring requirements of the study member. We have adapted questions used on ELSA/NHSD and cover ADLs (Activities of Daily Living) and IADLs (Instrumental Activities of Daily Living). We have also added questions on receipt of care (see HEBAL through CAHRI).
Children	Child health	This has been asked in previous sweeps - there is not enough scope to cover this in this survey.
Cognition	Cognition - request received to repeat cognitive tests given to cohort members previously to help monitor progressive decline	The cognitive tests conducted in recent sweeps are not suitable for web administration. We hope to administer an online battery of cognitive tests - separately to the web survey. In the web survey we will ask a question on self-rated memory (MEMORY).
Cognition	Self-reported memory	A question has been added from ELSA (MEMORY).
Dental health	It has been shown that number of teeth has been associated with cognitive decline, frailty, mental health and social isolation among others. Mortality risk perception	Measure perceived uncontrollable mortality risk (PUMR) using two 0–100 scale questions comparing estimated longevity with maximum health effort versus no effort	The expectations module does include questions about anticipated life expectancy - we ask what age people expect to live to, plus how likely it is that people will live to different ages (q24, YLQ40a and YLQ40b). We have not however included questions differentiating between levels of effort to maximise health.
Musicality	Include musicality phenotypes via self-report questions—covering emotion regulation through music, social musical reward, and musical rhythm—given their links to loneliness, social connection, language development, and cognitive function.	This is an interesting suggestion but there is not enough space in this sweep to cover these topics in the detail required. This questionnaire does include leisure activity questions on playing music and attending concerts (see MUSIC, CONCERT).

This is adapted from the NCDS Age 61 Life History Questionnaire.
Pain	Pain/chronic pain- impact on daily activities	Two questions have been added from the BCS70 Age 51 Survey (from the SF_36 - pain subscale). They ask how much pain they have had in 4 weeks (q20) and the extent that this interferes with work (inside and outside the home including housework) (q21).
Psychological resilience and sense of purpose	Psychological resilience and sense of purpose are key factors in healthy ageing. Suggested Questions: - To what extent do you feel your life has purpose? - How confident are you in your ability to adapt to changes in later life? - How often do you feel optimistic about the future? We agree this is an important area, but space constraints prevent us from covering it in the required detail in this sweep. We will consider it for the next main sweep.
